Hubballi - Dharwad

Hubballi, derived from the Kannada word "Hu-balli" meaning delicate flowering plants, was the original garden city of the Deccan carpeted with a tapestry of a myriad flowers. Hubballi is well known as a commercial as well as industrial centre, where as Dharwad is seat of learning. The climate of the city is extremely good throughout the year and especially Dharwad is known for its salubrious climate. After the capital city of Bangalore, Hubballi-Dharwad Twin City Corporation is the largest city Corporation in the State. It is a famous educational centre, and has three universities namely Karnatak University Dharwad, University of Agricultural Sciences Dharwad, and Karnataka State Law University, Hubballi. Government has also established Indian Institute of Technology and Indian Institute of Information Technology as well at Dharwad.

The city hosts web of temples and maths in and around the city. To name a few, Surya Devalaya at Lakkundi, Veeranarayan and Someshwar Temples at Gadag, DoddaBasappa Temple at Dambal can be seen around the city. ABOUT THE NEGOTIATION COMPETITION:

The negotiation competition would be an excellent opportunity for all law students nationwide. The competition will be held for two days. Negotiation as a method of Alternative Dispute Resolution mechanism encourages disputants to negotiate directly with each other before some other legal process that is very much like a courtroom process. It is an upcoming law arena devoted to preparing a generation of law professionals capable of facing future demands confidently. It is a unique initiative and one of the best avenues worldwide where students can experience a medley of dispute-resolution activities simultaneously.

ELIGIBILITY FOR PARTICIPATION:

- Students pursuing 3 years or 5 years law program from a University or Institute recognised by the Bar Council of India, New Delhi are eligible to apply.
- Only one team from each college/institute can participate in the event. Each team shall consist of 2 participants (Both Counsels) who will most adeptly negotiate with the differing party.

REGISTRATION:

- The registration will be on a first-cum-firstbasis, up to a maximum of 30 teams.

- Contract Law Tort and Consumer Law Service Law Intellectual Property Rights
- Family Law
 Property Law
 Company Law
 Any other ancillary laws

GENERAL GUIDELINES:

Team Composition:

- Each team shall consist of 2 negotiators (Both Counsels) for the event.
- Each team/participant shall have a Team Code/Individual code allotted at the registration desk, which shall be mentioned to the judges at the time of competition.
- The team composition shall not be altered after registration.

Language: The language of the competition shall be English.

Dress Code: The dress code for the competition shall be business formals.

ACCOMMODATION AND TRAVEL

- a. Accommodation and food shall be provided to the participating teams by the organisers from the evening of ${\bf 14}^{th}$ July, 2023 to the evening of ${\bf 16}^{th}$ July, 2023.
- b. The interested teams are required to inform the organising committee about the arrival of the team so as to enable them to make necessary arrangements. Food menu will consist of both north and south Indian meals.
- c. Separate accommodation arrangements are made for boys and girls.

RULES OF THE NEGOTIATION COMPETITION:

- 1. There will be five rounds. Preliminary I and Preliminary II, Quarter-final, Semi-final and Final Rounds.
- 2. Draw of lots shall take place soon after the inauguration.
- 3. Each negotiation round comprises three stages

Soon after the confidential information is given both teams shall proceed as per the following stages

- * Stage I. Pre Negotiation Stage
- * Stage II. Presentation of Written Plan of Action
- * Stage III. Negotiation Proceedings

4. Preliminary Round:

- a. There will be Preliminary Rounds 1 and 2. The teams shall present their case on one side in
- c. There is no pressure on parties to settle the dispute in the session. No special marks for settling disputes and no negative marking for failure to settle.
- d. Qualifying criteria from Preliminary rounds to Quarter finals Top 8 Teams shall qualify to quarter finals in the following way
 - 1. The teams with most wins qualify.
 - 2. In case there are more than 8 teams with 2 wins then highest scorers among them will qualify.
 - 3. In case there are less than 8 teams with 2 wins the teams with one win who have closely lost the other round will qualify.
 - 4. In case of tie for the 8th position the marks secured for written plan of action will be taken in to consideration.
 - 5. If the tie still subsists then the teams will be selected by way of draw of lots.

5. Quarter-Final Round:

- a. The Quarter Final Round will have a Time Limit of forty minutes for the conclusion of a Negotiation Session in which the teams shall conclude their deliberations.
- b. Negotiation problem will be the same for both the Quarter Final Rounds and Semi Final Rounds. Confidential information will be given thirty minutes in advance.
- c. Four Teams will qualify for the Semi Final Round by way of Knockout

6. The Semi-final Round:

- a. The Semi-Final Round will have a Time Limit of fifty minutes for the conclusion of a Negotiation Session in which the teams shall conclude their deliberations.
- b. Negotiation problem will be the same for both the Quarter Final Rounds and Semi Final Rounds. Confidential information will be given thirty minutes in advance.
- c. Two teams will advance to the Final Round by way of Knock out.

7. The Final Round:

- a. The Final Round will have a Time Limit of fifty minutes for the conclusion of a Negotiation Session in which the teams shall conclude their deliberations.
- b. The winners are adjudged by way of highest score.
- 8. There shall be 3 fact sheets. One for preliminary rounds, the second for quarter-final and semifinal rounds and the third for final rounds. Fact sheets of all rounds will be communicated to registered participants by 4th of July 2023.
- 9. The party to whom they have to represent and who is the opponent shall be determined by a draw of lots which shall take place one hour before the commencement of each round.
- 10. All participants must attend a briefing session before the commencement of the competition.
- 11. The participating teams are required to be present in the competition room fifteen minutes before every round.
- 12. Teams will not be allowed to share any material.

CONFIDENTIAL INFORMATION:

- 1. For all rounds of the competition, confidential Information will be released by the host college thirty minutes before the competition.
- 2. Teams are prohibited from disclosing the confidential Information to any other team or person throughout the competition.
- 3. No communication with the coach or other team members is permitted.
- 4. Any violation or breach of this will result in immediate disqualification from the competition.

DISCIPLINARY GUIDELINES:

- 1. All participants' grievances shall be addressed to the Director of the KLE Law Academy in writing.
- 2. The grievance redressal committee reserves the right to disqualify any team or participant or impose any other penalty for misconduct on the part of any team member during the competition. In case of any doubt/dispute, the grievance redressal committee's decision shall be final.

STAGES OF THE NEGOTIATION PROCESS:

Each Round shall include:

- Pre-Negotiation Stage Stage I
- Presentation of Written Plan of Action-Stage II
- Negotiation and Summarizing the Outcome Stage III

STAGE I-Pre Negotiation Stage

- Teams shall prepare a written plan of action on behalf of their client within the allotted time.(See-Annexure I)
- The written plan of action should be submitted before the judges.
- The written plan of action shall consist of i) Identification of interests generally ii) Identification of issues for Negotiation iii) Different options explored to satisfy the identified interests during negotiation, iv) Exploring the alternatives if negotiation fails v) How to utilise identified alternatives etc. (See-Annexure II)

STAGE II- Presentation of Written Plan of Action

- The stage is for the submission of the written plan of action followed by oral presentation before the judges including the opening statement.
- Written plan of action shall not exceed Four Pages.
- The team shall choose one participant only to present the plan of action.
- Opponent team shall go out at the time of one team's presentation of the plan of action.
- Judges may seek clarifications.

STAGE - III Negotiation Proceedings

- The participants may set up their negotiation tables before the judges arrival.
- Teams shall not alter the facts provided in the fact sheet. In case of any doubts, the interpretation supplied by the organising committee shall remain final.
- During the negotiation each team shall be entitled to one break of 2 minutes, which is inclusive of the allotted time.
